Challenges the Autism Community is Facing

- Abrupt discontinuation of educational services
- Closure of day programming
- Closure of clinics and shift to telehealth
- Mental health challenges for individuals and caregivers
- Lack of connection to community opportunities/supports
- Severe disruption of community employment
- Discontinuation of respite relief for families
- Disruption of much-needed routines
- Loss of income for some families
- Challenging behaviors
- Access to healthcare with appropriate supports



Federal COVID Legislation

MARCH 6: COVID 1

Coronavirus Preparedness and Response Supplemental Appropriations

Provides \$8.3 billion in emergency funding for federal agencies to respond to the coronavirus outbreak

MARCH 18: COVID 2

Families First Coronavirus Response Act

- Provides emergency paid sick and family leave
 - DOL has provided Q&A regarding these provisions of the law
- Tax credits
- Free COVID-19 testing (where available)
- Expands food assistance and unemployment benefits
- Increases Medicaid funding

MARCH 27: COVID 3 Coronavirus Aid, Relief and Economic Security (CARES) Act

Provides \$2 trillion in funding for provisions, including:

- Economic impact payments to most Americans
- Increased unemployment benefits
- Hundreds of billions of dollars to address the public health response
- Assistance for small businesses and other employers to retain employees and keep their businesses operating
- Billions of dollars for schools
- Extends the Money Follows the Person program through November



Federal COVID Legislation

APRIL 24: COVID 3.5

Paycheck Protection Program and Health Care Enhancement Act

Interim bill to replenish small business assistance program and address other issues:

Limited scope to address Paycheck Protection
 Program and funding for hospitals and testing.

COVID 4/5

Additional Relief and Stimulus

Timeline still TBD – House will likely introduce/pass bill first – not back in session until at least next week.

What will be contained in these bills: ???

- Examples of potential items:
 - \$ for the public health response
 - Additional economic relief for individuals and small businesses
 - \$ for state and local governments
 - \$ for education
 - Additional nutritional assistance
 - Housing assistance
 - USPS finances
 - Infrastructure investment



Implementation of the COVID bills - A few issues of note

- Economic Impact Payments and SSI
- Distribution of education dollars
- IDEA Waiver Report
- Emergency Paid and Family Leave



Our advocacy priorities during the COVID crisis

- Additional funding for home and community-based services (HCBS)
- Additional funding to meet the educational needs of students with autism
- Protecting the <u>rights of students under the Individuals with Disabilities Education Act</u> (IDEA) and other laws
- Expanded access to telehealth services for health care needs
- Eligibility for \$500 economic impact payments for dependents over age 17
- According caregivers of adults with disabilities the <u>same emergency paid sick and family medical</u>
 <u>leave</u> policies accorded caregivers of children
- <u>Preventing discrimination</u> in treatment decisions and care allocation based on disability

Florida's State Budget and Selected Legislative Session Outcomes - James


- Legislative Session Over/Change of Schedule Tested for Election Years
- State Budget Health pre-COVID
- Some Autism-Related Session Outcomes:
 - ABA Provider Licensure Issue
 - SB 82 iBudget Program changes/Take Effect July 2021 (details next slide)



Florida's State Budget and Some Legislative Session Outcomes - James

- SB 82 iBudget Program Changes Details:
 - Eliminating the statutory criteria for authorizing supplemental funding for a client, and, instead, creating a standard definition of a "significant additional need" to judge supplemental funding requests and centralizing that process for consistency at APD HQ;
 - Requiring waiver support coordinators to be employed by qualified waiver support coordination agencies;
 - Requiring all service providers to bill for services and submit all required documentation through the agency's electronic client data management system;
 - And, the Legislature included new money in the budget to fund additional slots in the iBudget program.







HEALTHCARE - Telehealth Services

- Medicaid Coverage of autism-related services via telehealth has been authorized within Medicaid. Some providers are concerned about the updated health care codes and 30 day at a time service plans [under iBudget only], and we are looking into that. - Private Insurance The Florida Office of Insurance Regulation (OIR) made this statement (not a mandate): "OIR believes innovative use of technology can combat spread of COVID-19 by allowing Floridians to remain in their homes without losing access to critical care. This memorandum encourages all health insurers, health maintenance organizations, and other health entities." https://www.floir.com/siteDocuments/OIR-20-06M.pdf



HEALTHCARE/1135 MEDICAID WAIVER

Florida was approved for an 1135 emergency waiver by the federal agency CMS (Centers for Medicare and Medicaid Services). This allows for a great deal of flexibility related to authorizations/benefits in Medicaid health plans including the ability to:

- Waive certain provider screening requirements
- Postpone deadlines for revalidation of providers
- Allow certain out-of-state providers to be utilized in Florida
- Allow service provision in alternate settings, including unlicensed settings
- Suspend fee for service prior authorization requirements
- Extend existing prior authorizations

HOME AND COMMUNITY-BASED SERVICES/APPENDIX K

The Centers for Medicare & Medicaid Services (CMS) developed the Appendix K to help states accelerate changes to their 1915(c) home and community-based services waiver operations or to request emergency amendments during a natural disaster or situations like the nation is facing in COVID-19.

HOME AND COMMUNITY-BASED SERVICES/APPENDIX K

Florida's approved Appendix K application allows for HCBS flexibilities including:

- Temporarily exceeding service limitations on certain <u>lifeskills development and adult</u> day training, as well as flexibility on the locations to hold these;
- Temporarily allowing for <u>payment of personal supports and services when a covered</u> individual must be in a hospital setting such as for COVID treatment;
- Retainer payments made to service providers in certain circumstances;
- Allowing a family member to be paid to render services to a covered individual;
- Allowing other practitioners in lieu of approved providers, in some cases;
- Allowing for <u>virtual</u> evaluations, assessments, and person-centered care planning sessions;
- Adjusting prior approval/authorization elements;
- Allowing adult day program staff to provide some services in the covered individual's home.



Special Education/Early Intervention/Transition

Florida will receive funds from the COVID-3 stimulus package/Education Stabilization Fund:

K-12 \$ 770 million

Governor's Discretionary \$ 173 million

We are advocating that students with autism receive appropriate supports and services, including but not limited to:

- Acquisition and dissemination of <u>hardware</u>, <u>software</u>, <u>communication devices</u>, <u>and other assistive technology</u> for the school closure period
- Appropriate <u>transition from early intervention to special education</u>
- <u>Services not received during the time of school closures and remote learning be</u> <u>made available in person at the earliest possible (safe) time</u>
- Appropriate transition out of special education to adulthood
