THESE EFFORTS INCLUDE OFFERING 10,000 WHOLE GENOME SEQUENCES THAT ARE BEING ACCESSED BY MORE THAN 180 RESEARCHERS FROM 40 INSTITUTIONS ACROSS 16 COUNTRIES. RESEARCH FUNDING WAS PROVIDED TO TWO INNOVATIVE STUDIES FOCUSED ON UNCOVERING THE RELATIONSHIP BETWEEN AUTISM AND AUDITORY PROCESSING. OUR FUNDING ALSO RESULTED IN 11 PUBLICATIONS DURING THIS 3-MONTH PERIOD.
